TERMS & CONDITIONS

1. Participants commit to raising £250 sponsorship.
2. Participants run solely and exclusively for One to One Children's Fund.
3. Participants are responsible for ensuring their own fitness to participate in the Brighton Marathon. This event is not recommended for those with any infirmity unless they checked with their GP who agrees that they are fit to undergo the challenge prior to the event. We reserve the right not to accept an application without a certificate from a participant's GP if we have concerns about their fitness.
4. If, for whatever reason, participants are unable to take part in the Brighton Marathon 2012, they will inform One to One Children's Fund immediately and withdraw from their place. Participants who cancel will not be liable to the sponsorship commitment, however they will be liable for the full registration cost incurred by the charity plus an administration fee, equating to an extra charge of £75 to the participant. For cancellations processed before 15th February 2012 the Charity may waive this charge if they are able to fill the vacant place. Deferment to 2013 may be possible for a charge of £50.
5. One to One Children's Fund does not accept any liability whatsoever for any personal accident, injury, public liability, loss or damage to personal effects.
6. Any participant withdrawing from the event either before or during the event must notify One to One Children's Fund and (if on the day) the event manager immediately.
7. By taking part, participants confirm that all photographs taken during the event may be used by One to One Children's Fund for their publicity of future events.
8. The One to One Children's Fund reserves the sole right to amend event details and to reject any applicant. Every effort will be made to inform participants of any change we consider necessary to make.
9. Participant's details will be stored for the purposes of event management, and will not be passed on to third parties, other than to the Brighton Marathon as required.
10. One to One Children's Fund will add participant's details to their mailing list for the purposes of informing about the work of the charity and future fundraising events.
